Programme Overview

The CACHE Level 2 Certificate in Early Years Education and Care is designed for the learner with little or no experience in childcare. The aim of this international qualification is to prepare learners to work with children between birth and five years. This qualification covers children aged 5 years and under and consists of mandatory units as well as optional units.

What are the entry requirements?

How is it assessed?

Do you need to be working to take the qualification?

Learners will need to be working, volunteering or on a practical placement as an important part of the assessment process involves evaluating skills in real working situations. CACHE recommends 250 placement

How long does it take to complete?

This qualification will take one year to complete.

When is this qualification available?

This qualification will be open for registrations from 15th March, 2016.

Qualification Structure

We have structured the units around the following four themes (Group A)

- 1 Introducing the role of the early years practitioner
- Legislation, framework and professional practice
- 3 Play, development and learning for school
- 4 Professional development

Learners must achieve a total of 33 credits: 29 credits from mandatory group A; plus 4 credits from optional group B.

Optional Units (Group B)

- 1 Support healthy lifestyles for children through the provision of food and nutrition
- 2 Support healthy lifestyles for children through exercise
- 3 Support children with additional needs
- Support creative play

What could this qualification lead to?
